GUIDELINES FOR INTERNSHIP FOR STUDENTS FROM RECOGNISED INSTITUTIONS/ COLLEGES-2026

These guidelines are issued to engage Undergraduate/ Postgraduate students of Law/ Engineering/Management/Economics/Energy Economics or Research Scholars from recognized universities/institutions in India, as "interns". The 'interns' shall be given exposure to various sections within MPERC, Bhopal. Following are the terms and conditions for the Internship Programme: -

i. **Objective of the Internship Programme: -**

To acquaint students with the process of making regulations, tariff determination process, administration work and new developments in power sector.

ii. **Framework of the Internship Programme: -**

Eligibility	Bona-fide Undergraduate/Postgraduate students of Law/ Engineering/Management/Economics/Energy Economics Undergraduate/ Postgraduate or Research Scholars from any recognized University/ Institution within India
Duration	Minimum One (01) and Maximum up to Two(02) months
Evaluation method	After completion of the internship programme, the intern shall submit Report/Presentation on the overall learning during Internship Programme
Document after Successful completion of Internship	Certificate

iii. **Internship Schedule: -** Internship Schedule will be decide by the Commission Secretary at the time of Induction of interns.

iv. **Terms and Conditions for engaging Interns: -**

- The internship shall be on unpaid basis. No allowance for out-stationed students shall be allowed.
- Before starting the internship, the student shall sign an undertaking in the format prescribed by the Commission.
- Internship is for maximum period of two months and intern shall not have any right whatsoever to claim for regular appointment or contractual engagement in MPERC.
- The sanctity of the Commission's confidentiality shall be maintained by intern.

- e. No confidential documents or petition shall be handed over to the Interns.
- f. Any misconduct or misbehavior during the internship will lead to cancellation of Internship.
- g. No of students at a time may be considered for Internship Programme decided by the chairperson but in any case, not more than four (04) students in same tenure of internship may be engaged.
- h. The students have to produce recommendation/ reference letter from their respective college /institution at the time of applying for internship programme. Without the aforesaid letter, the application shall not be considered.
- i. Commission reserves the rights to reject application for internship without giving the reason whatsoever.
