No.31 -MPERC- 05 /01/2022- In exercise of powers under Section 87(1) of the Electricity Act, 2003 and in supersession of earlier notification No. 252/MPERC/2018 dated 9th February, 2018, the Commission hereby re-constitutes the State Advisory Committee from the date of publication of this notification in the M.P. Official Gazette.

2. The object of the State Advisory Committee shall be to advise the Commission on the matters mentioned under Section 88 of the Electricity Act, 2003.
3. The functioning of the State Advisory Committee shall be governed by the MPERC (Constitution of State Advisory Committee and its functioning) Regulations, 2004 and its amendments.
4. The term of Members of the State Advisory Committee shall be three years from the date of publication of the notification in the official gazette.
5. The Chairman and the Members of the Commission shall be ex-officio Chairman and Members of the State Advisory Committee respectively. Principal Secretary Food, Civil Supplies and Consumers Protection, Govt. of M.P. shall also be the ex-officio member of the Committee.
