Heard the petitioner and the respondents. The respondents No. 1 & 2 submitted that they have submitted Affidavits dated 10/05/2023 & 11/05/2023 respectively in compliance to directions issued by Commission's daily Order dated 25/04/2023 in the matter.

2. The Commission observed that a new development has come to its knowledge. A letter dated May 20, 2023 of Shri Anil Kumar, Secretary, Energy Watchdog, NGO, New Delhi has been received in the Office of the Commission by e-mail and that it raises substantive issues related to transparency in the process of bid finalization. Hence, the Commission is of the view that the letter be taken on record and copy of the letter be served upon all respondents and the petitioner to seek their responses in the matters raised in this letter.
3. The Commission has also decided to include the Government of MP, Energy Department, Mantrallaya, Bhopal as Respondent in the petition.
4. The Petitioner and all Respondents are directed to submit their response on the aforesaid letter, to the Commission, within two weeks.
5. The case is fixed for hearing on the **13th June, 2023**.
