The Petitioners have filed the subject petitions under section 86(1)(b), (e) & (f) of the Electricity Act, 2003 read with Regulation 10 of the MPERC (Conduct of Business) Regulations, 2004 for seeking compensation due to change in law due to increase in capital cost for installation of solar power plants under the KUSUM YOJNA COMPONENT – A. By affidavit dated 19.10.2022 all the Petitioners have also filed additional documents in the subject matter.
