Shri S.K. Saxena, (CE) and Shri Salil Choudhary appeared on behalf of petitioner.

M.P. Power Generating Co. Limited has filed the subject petition for True-up of Generation Tariff of MPPGCL's Power Stations for FY 2020-21 determined by the Commission vide Multi Year Tariff order dated 19.05.2021. The Petitioner has also filed an Interlocutory Application (IA) for condonation of delay in filing the subject true-up petition.

2. Petitioner was heard on delay on submission of subject True-up petition. It is pointed out that there is inordinate delay in submission of subject petition, which is noted by the Commission. It is reemphasized by the Commission that filing of True-up petition is time bound exercise stipulated under Regulations and delay in filing of true-up petition is violation of Regulations, which may attract penal action. Therefore, petitioner is directed to file Tariff/True-up Petition within prescribed time limit in future.

3. After considering the submission for condonation for delay, the subject petition is admitted. The petitioner is directed to serve copy of the petition to all Respondents within seven days and report compliance of service to the Commission. The Respondents are directed to file their replies to the subject petition within fifteen days, thereafter. A copy of aforesaid replies be served to the petitioner simultaneously. The petitioner may file rejoinder within seven days, thereafter.

The next date for hearing, if required, shall be informed to the parties.
