PUBLIC NOTICE

M.P. Power Generating Company Limited (MPPGCL) has filed a petition for True up of Generation Tariff of Power Stations of MPPGCL for FY 2022-23, determined by the Commission vide its Multi Year Tariff order dated 19.05.2021 read with corrigendum dated 09.09.2021. The subject petition has been filed under section 62 & 64 of the Electricity Act 2003 read with Madhya Pradesh Electricity Regulatory Commission (Terms and Conditions for determination of Generation Tariff) Regulations, 2020.
