Madhya Pradesh Urja Vikas Nigam Limited has filed a petition under section 86(1)(e), section 61(h) of the Electricity Act, 2003 for determination of Pre-fixed levelized tariff for sale of power from decentralized Solar Power Plants having capacity of five hundred (500)kW to two (2)MW or such other capacity as per notification of Govt. of India, to be set up under Component-A of the Pradhan Mantri Kisan Urja Surakhsha evam Utthan Mahabhiyan (PM KUSUM) Scheme introduced by Government of India (GoI).
