## M. P. ELECTRICITY REGULATORY COMMISSION BHOPAL

IN THE MATTER OF REQUEST FOR GRANTING CONSENT TO RUN 500 KVA AND 750 KVA D.G. SET BY THE PETITIONER - APPEAL THEREOF UNDER SECTION 10(f) OF M.P. VIDYUT SUDHAR ADHINIYAM, 2000.

ORDER (Passed on this day 18th May, 2004)

None appears for the petitioner.

Shri K.M.Vyas, Additional S.E., O/o S.E.(O&M), MPSEB appears for the Board.

The petitioner submits that MPERC vide Order No. 2317 dated 10.4.2003 in Application No. 1484/02 has granted consent to the petitioner to run 500 KVA and 750 KVA D.G. set subject to the condition that if the petitioner reduces his contract demand beyond 1.5 times, the consent will stand cancelled. The petitioner further submits that as per the order of the Commission, MPSEB has sealed one of its 500 KVA D.G. set which the petitioner wants to dispose off. The petitioner requests the Commission to instruct the MPSEB to open the seal on the generators which is now in contravention to the Electricity Act, 2003.

The respondent Board in its reply submits that in light of the new Captive Power Policy dated 24.1.2003 the petitioner's above request may be considered.

As per the provisions of Electricity Act, 2003 (36 of 2003) which came into force on 10.12.2003 in the State, no consent for installation and running of captive generating plant is required in the present situation. Therefore, the Commission orders the Respondent to open the seal of 500 KVA D.G. Set. The petitioner is free to use or dispose of the above D.G. set. Case is closed.
