APPLICATION FOR ESTABLISHMENT OF WEG AND FOR PERMISSION U/S 86(1) (C) OF THE ELECTRICITY ACT, 2003 FOR WHEELI POWER GENERATED FROM 1.25 MW &SUZLON MAKE WEG THROUGH EXISTING MPEB NETWORK GRID FOR CAPTIVE CONSUME

<u>ORDER</u> (Passed on this day 25th January, 2005)

Respondent

Petition is in the matter of establishment of WEG of 1.25 MW Suzlon Industry, Dewas and for wheeling of power for consumption through Board s grid.

2. Petitioner is a registered company and also an HT consumer of the respondent Board. The petitioner desires to install WEG for generation of electrical power in the Dewas near Nagda Hills for Captive use in its factory at Mangaliya, Indore. The petitioner states that it desires to supply surplus power, if any, to the Respondent Board @ Rs. 2.25 per unit as per the existing poli GoMP according to which wheeling of power from the point of generation to any other place for own use/ sale of power to third their factory premises, will be allowed through MPEB transmission/distribution system on payment of 2% wheeling charges. F is also ready to supply surplus power at any other rate determined by the Commission. The petitioner requests the Commission permission for wheeling of power and to allow for construction and laying of dedicated transmission line from the point of gene the point of nearest grid Sub-station of the Board.

3. The representative of the Board requests the Commission to grant consent to the Petitioner for establishing 1.25 N Electric Generators near Nagda Distt., Dewas for captive use by wheeling power to the petitioner s factory at Mangaliya, Indore.

4. Considering the facts and circumstances of the case, Commission grants permission to the petitioner for wheeling through Board's grid from the captive generation plant of 1.25 MW ♦Suzlon♦ make WEG through existing MPEB network grid fo consumption in its factory at Mangaliya, Indore on payment of wheeling charges as per the existing captive power policy of t Government for five years from the date of this order subject to revision to be made by the Commission. Commission also a petitioner to sell its surplus power, if any, to the Board at the rate Rs.2.25 per unit till the decision of pending review petil 104/04). The above permission is subject to the following other conditions:-

i) The technical and other commercial matters should be settled between the Board and the petitioner.

ii) The supply and sale of power shall be governed by the policy of the State Government and other provisions of I made applicable from time to time and also as per terms and conditions of the PPA to be executed by the petitioner with the MPS
iii) The petitioner shall comply with the provisions of the Madhya Pradesh Vidyut Sudhar Adhiniyam 2000, Electricity and other laws applicable, the Regulation of the Commission, Technical Codes, Standards of Performance or any other guideline by the Commission from time to time.

iv) The petitioner shall furnish to the Commission such information required for the purpose of the discharge of the of the Commission, as the Commission may require from time to time.

v) The Commission shall be entitled to impose any other conditions as the Commission considers appropriate fron time, including the terms of revocation or modification of the approval.
