2. The Petitioner has filed this petition in the matter of permission for change of option from captive consumption to sale to utility for the remaining period of operation.

3. During the hearing, the representative of the Petitioner has submitted that four Nos. of WEGs each of 225 KW rating are installed at location No. 46, 60, 61 and 49 in the Windfarm at Jamgodrani. The Power Purchase Agreement for the WEGs at location No. 60 & 61 for third party sale has expired on 29.09.2009 and for location Nos. 46 & 49 is expiring on 19.10.2009. They have further requested that permission be granted for sale of energy provided by these 4 Nos. of WEGs to the utility through M.P.Tradeco for the remaining period of operation of WEGs. The representatives of the Petitioner have also submitted that they are ready to execute PPA in terms of provisions of Tariff Order dated 21.11.2007 for procurement of power from the WEGs.

4. During the hearing, the representative of the Respondent No.I has submitted that the PPA for the WEGs installed at location No. 46 & 49 for a period of 12 years shall expire on 24.07.2010

instead of 19.10.2009 mentioned by the Petitioner . He has also submitted that as the PPA in respect of WEGs at location No. 46 & 49 shall expire on 24.07.2010 i.e. after ten months, therefore, the permission for switching over to sale of power to utilities from the aforesaid 2 Nos. WEGs may be granted after expiry of agreement.

5. On hearing both the Petitioner and the Respondent, the Commission has considered the request of the Petitioner and directs the Respondent No. I to allow sale of energy provided by 4 Nos. of WEGs to the utilities through MP Tradeco in terms of the provisions made in Tariff Order dated 21.11.2007 for procurement of power from the above existing WEGs w.e.f. the date just after the date of expiry of earlier PPAs.

8. With the above directions, the Petition No. 44/2009 stands disposed off.
