**ORDER  
(Passed on this day 05<sup>th</sup> April 2007)**

1. Shri B.K.Patel appears on behalf of the petitioner.  
2. Shri D.K. Ojha S.E. (Comm.) O/o. CMD (WZ) appears on behalf of the Respondent Company.  
3. The petitioner M.P.Urja Vikas Nigam Ltd, urja Bhavan, Shivaji Nagar, Bhopal. has filed this petition on 08.12.2006 in the matter of sale of power to utility generated by Wind Farm proposed at Mahuriya Shajapur.

4. The respondent has submitted reply today. It is stated by the petitioner that the West Discom shall be purchasing power from Wind Farm to the extent of 0.5% of its annual requirement as directed by the Commission vide Tariff Order dated 11.04.2004 read with revised order dated 01.03.2006. It is further stated by the respondent that on receipt of the order from the Commission, the petitioner shall be provided a copy of the model agreement approved by the Commission for execution.

1. The case is listed today. The Commission observes that as per the provisions of the Electricity Act 2003 no permission is required from the Commission to install the wind generating plant. However, the petitioner stated that to get the necessary clearances, PPA with the Discom is required and hence the Commission may direct the Discom to enter into PPA. The Commission directs respondent to give a copy of the model agreement to be executed between the petitioner and the respondent.

2. The respondent has already confirmed in the reply that the utility shall purchase power from Wind Farm as and when the wind generating plant is commissioned at the rate decided by the Commission. Therefore, nothing more is required in this case. With the direction aforesaid, the Commission decides to close the case.
