## M.P. ELECTRICITY REGULATORY COMMISSION BHOPAL

**SUB:** IN THE MATTER OF ESTABLISHMENT OF WIND ELECTRIC GENERATORS (WEG) UPTO 1.25 MW CAPACITY 'SUZLON' MAKE IN THE VILLAGE NAGDA, DISTT. DEWAS.

## ORDER (Passed as on this day of 25th April, 2006)

Shri B.K. Dubey, Advocate and Shri A.K. Pandey appears on behalf of the petitioner.

Shri C.K. Dixit, Additional S.E., O/o SE (Comm.) appear on behalf of Respondent.

2. Petitioner submits that it is desirous of installing 1.25 MW WEG 'Suzlon' make for generation of electrical power for captive use in its factory at Pithampur, Dist. Dhar and also for sale of surplus power, if any, to the respondent. Petitioner further states that as per the provisions of section 39(1) of the Electricity Act, 2003 and existing policy declared by the GoMP regarding wheeling of power, petitioner will be allowed to wheel the power from the point of generation to any other place for party's own use/ sale of power to third party through respondents system on payment of 2% wheeling charges irrespective of distance.

3. M/s. Suzlon Infrastructure Ltd. has developed facility for wheeling of electricity from point of generation to the nearest 220 KV substation of the respondent as per the specifications at their own cost. The petitioner undertakes to supply surplus power to the Board @ Rs. 2.25 per unit in terms of Clause 5 of the policy and petitioner also undertakes to be bound by the terms and conditions as may be fixed by the Commission. The petitioner therefore prays to the Commission to grant permission for wheeling of power through the network and then to the respondent from the site of WEG for captive consumption on payment of 2% wheeling charges for wheeling of power and also to direct the respondent to purchase the surplus power from the company.

4. During the course of hearing today the petitioner states that they have installed the machine in the West, drawing thorough from the Central and is having an agreement with MPSEB.

5. In the reply submitted by the Respondent it has requested the Commission to grant consent to the Petitioner for establishing 1.25 MW WEG for captive use subject to certain conditions.

6. Commission heard the Petitioner and the Respondent. Commission grants permission to M/s. Mittal Appliances Ltd. for establishing 1.25 MW Wind Electric Generators near Nagda Distt., Dewas for captive use by wheeling of power to their factory situated at plot No. 75 sector 3, Pithampur Dhar (M.P.) for five years w.e.f date of commissioning of the Wind Electric Generator at the existing rate of 2% wheeling charges till its revision by the Commission and also directs the respondent to purchase the surplus power from the applicant company @ Rs. 2.25 per unit or determined by the MPERC subject to the following other conditions:-

i) The technical and other commercial matters should be settled between the respondent and the petitioner.
ii) The wheeling of power shall be governed by the provisions of law to be made applicable from time to time and also as per terms and conditions of the PPA to be executed by the petitioner with the respondent.
iii) The petitioner shall comply with the provisions of the Madhya Pradesh Vidyut Sudhar Adhiniyam 2000,

and other laws applicable, the Regulation of the Commission, Technical Codes, Standards of Performance or any other guidelines issued by the Commission from time to time. iv) The petitioner shall furnish to the Commission such information required for the purpose of the discharge

of the functions of the Commission, as the Commission may require from time to time.

v) The Commission shall be entitled to impose any other conditions as the Commission considers appropriate from time to time, including the terms of revocation or modification of the approval.

Therefore in view of the aforesaid, Commission decides to close the case.

Ordered accordingly.
