Shri Manoj Dubey, Advocate and Shri G.L. Pandey, DGM of MPPMCL appeared on behalf of the petitioner.

- 2. The petitioner M.P. Power Management Co. Ltd. filed the subject petition and broadly prayed to the Commission to:
 - (i) Admit this petition on record and treat it as complete;
 - (ii) Review the applicability of APPC rate in solar tariff order dated 01.01.2012 and 08.08.2016, towards inadvertent flow of energy into the grid from solar projects and prescribe rate for inadvertent flow as in case of Wind Tariff order dated 17.03.2016;
 - (iii) Consider revised rate as Rs. 1.00 (one)/kWh and shall be applicable on existing as well as future PPWAs from the date of order of the Commission in this Petition or from such date as the Commission may fix.
- 3. The case was first listed for motion hearing on 10.07.2018, wherein the petitioner sought adjournment for filing application for condonation of delay. By daily order dated 12.07.2018, the Commission considered the petitioner's request for adjournment and directed them to file the application for condonation of delay along with requisite fee by 20.08.2018. The petition was listed for next motion hearing on 28.08.2018. The petitioner submitted the application dated 27.08.2018 for condonation of delay.
- 4. During the motion hearing on 28.08.2018, the Commission observed that the petitioner had filed the application dated 27.08.2018 without requisite fee. By the daily order dated 06.09.2018 the Commission directed the petitioner to deposit requisite fee by 18.09.2018, positively. The petition was listed for next motion hearing on 25.09.2018.

Sub: In the matter of petition under Section 86(1)(E), 61(H) and 62 of the Electricity Act, 2003 for review of rate for procurement of inadvertent flow of electricity from solar projects.

- 5. During the hearing on 25.09.2018, the petitioner requested the Commission to allow some more time for remittance of the requisite fee on their application for condonation of delay. By daily order dated 26.09.2018, the Commission granted the permission. The case was listed for next motion hearing on 09.10.2018.
- 6. During the motion hearing on 09.10.2018, the petitioner once again requested the Commission to allow some more time for remittance of the requisite fee on their application for condonation of delay.
- 7. The Commission observed that despite giving sufficient opportunities, the petitioner had not filed the complete petition as per the requirement of MPERC (Conduct of Business), Regulations, as amended from time to time and asking repetitively for adjournment. It appears that the petitioner is not serious in pursuing to its filing. The Commission has therefore, decided to dismiss the petition on account of filing of incomplete petition.
- 8. In view of the above, Petition No. 26 of 2018 stands disposed of Ordered accordingly.
