ORDER

Petition No. 7 of 2007

- 2. During the course of last hearing the Commission had questioned the respondent as to why the credit is not being given to the petitioner. Commission had further enquired about the practice followed in the matter previously for the power fed in the grid by WEGs. The respondent may seek authentic data of the power injected in the grid by the WEGs from the West Discom and the SLDC. The Commission directed the Respondent to sort out the problems within two weeks period and the compliance report had to be submitted on the next date.
- 3. Today the Commission again questioned the respondent as to why the credit is not being given to the petitioner. The respondent West Discom submits that a clause is to be incorporated in the agreement that could not be completed. The respondent Central Discom submits that the data of the power injected in the grid by the WEGs has not been received from the West Discom. The respondent seeks more time of a day for finalization of agreement. He also assured the Commission that the data will be faxed tomorrow to the Central Discom. The Commission directs both the respondents to complete the formalities within 2 days and to give credit to the petitioner and submit the compliance report within a week. With the direction aforesaid, the Commission decides to close the case.
