ORDER (Petition No. 40/06 & 46/06)

During the hearing on 15.11.2006, Shri D.K. Ojha, ASE appeared on behalf of M.P. Paschim Kshetra Vidyut Vitaran Co. Ltd., Indore and Shri O.S. Parihar, SE appeared on behalf of M.P. Poorv Kshetra Vidyut Vitaran Co Ltd., Jabalpur.

2. The petitioners have submitted the petitions on the following issues for review of tariff order dated 31.3.2006.

a) Tariff for private Nursing Homes and Hospitals.

b) Billing of un-metered domestic and agricultural connections on the basis of assessed consumption.

c) Tariff for consumers situated in rural areas but getting supply from urban feeders.

d) Reduced tariff for HT irrigation and public water works.

- e) Tariff for consumers of township/multi consumers complexes.
- f) Reduced tariff for REC (Rural Corporation Societies).

3. The Commission vide order sheet dated 15.11.2006 had directed all the Discoms on the following issues:--

- (a) Road map for 100 % meterisation of un-metered domestic/agricultural connections.
- (b) Basis of assessment for un-metered domestic/agricultural connections.

4. The Discoms have submitted replies on the following issues:--

- (a) Reclassification of Private Nursing Homes
- (b) Road map for 100 % meterisation of un-metered domestic/agricultural connections.
- (c) Basis of assessment for un-metered domestic/agricultural connections.

5. The Commission has considered the views/commitments of the Discoms and issues following directions:--

(i) The matter regarding review of tariff order dated 31.3.06 was delayed due to non-submission of required data by the Discoms. Now as the Discoms have submitted that they are not interested to pursue the above matter further, the Commission directs that

classification of private nursing homes and hospitals into non-domestic shall remain under domestic category during FY07 and this issue may be reconsidered during determination of tariff for FY08.

(ii) Regarding billing of un-metered domestic and agricultural connections , the Commission directs the Discoms to issue bills on the following assessed units during FY07 :--
