- 2. The petition has been filed for truing up of retail supply and distribution ARR of West Discom for FY 2013-14. The petitioner has prayed the Commission to approve a net gap of Rs. 2,335.57 Crore for FY 2013-14. The summary of filing for true-up of ARR for FY 2013-14 is as given in table below

The Commission observed that Retail Supply tariff petition (P.No. 01 of 2013) for FY13-14 was jointly filed by the petitioner along with co-petitioners MPPMCL and East & Central Discoms together through a common petition no. 01 of 2013. Thus, the Commission deemed it appropriate that true up petitions for FY13-14 should not be dealt in isolation for each Discom. The Commission, therefore, directs the petitioner to file the true up petition along with MPPMCL and East & Central Discoms in consolidated manner similar to Retail supply tariff petition filed by them for FY13-14 so that a holistic view be taken by the Commission in the matter. The instant petition, therefore, stands disposed of with the direction that the petitioner will not require to remit the fee when the consolidated petition is filed.
