Sub: In the matter of Long Term Open Access to MPAKVN for their SEZ Complex at Pithampur Distt. Dhar – Relinquishing of the capacity in pursuance of provisions of Clause 8.17 of the Open Access Regulations - Revision in the Transmission Tariff Order for FY 08.

2. Consequent to the Commission's order dated 24-04-2007 in the subject matter wherein the Commission directed the respondent MPAKVNL to inform the Commission whether to continue with the capacity allocation of 25 MW during FY 08, the respondent has submitted its request before the Commission to reduce the allocation of Transmission Capacity from 25 MW to 12 MW during FY08 for its SEZ complex at Pithampur.

3. As per the Transmission Tariff order for FY08, the existing transmission system capacity allocation is given below:

With reduction in the allocation of Transmission system capacity to SEZ from 25MW to 12 MW there will be an additional capacity of 13 MW is available for the long term users of Transmission system. The Commission has pondered over the issue and considered the request put-forth by MPAKVNL. The Transmission system capacity allocation in favour of MPAKVNL for its SEZ at Pithampur shall be 12 MW for FY08. Further the Commission has decided to distribute the Transmission system capacity of 13 MW among the three Distribution Companies of the State in the same ratio that had already been considered earlier. Accordingly, the revised allocation for FY08 i.e. from 1/4/2007 to 31/3/2008 will be as below:
