Shri M. Naveen Kumar, Director of the company appeared on behalf of the petitioner.

2. The petitioner, Madhya Pradesh Biomass Energy Developers Association has filed this petition seeking fixation of the tariff parameters for Rankine Cycle based biomass power projects which are using Air Cooled condenser in the state of Madhya Pradesh with reference to the generalized tariff fixed by the Commission for procurement of power from biomass based power generation projects vide its orders dated 07.08.2007 & 03.05.2013. The case was listed for motion hearing on 24.11.2015.

3. During the hearing, the petitioner restated the contents of the petition and requested to consider the fixation of the tariff parameters for existing biomass power projects which are using Air Cooled condenser in the state of Madhya Pradesh for which generalized tariff was issued earlier by the Commission.

4. Having heard the petitioner and on considering its written submissions, the Commission has noted that the tariff order for procurement of power from biomass based power projects has already been issued on 07.08.2007 & 02.03.2012 (as amended from time to time) and generalized tariff was fixed for all types of biomass power projects. The control period of the tariff order shall expire on 31.03.2016. As such, the request of the petitioner
