IN THE MATTER OF DELETION OF CONDITION FOR USE OF 50% OF THE TOTAL MONTHLY ENERGY REQUIREMENT FROM BOARD'S SUPPLY.

ORDER (Passed on this day 18th June, 2004)

Shri B.K.Dubey, Advocate appears for the petitioner.

None appears for the Respondent Board in spite of the notice.

The petition is in the matter of deletion of condition for use of 50% of the total monthly energy requirement from Board's supply.

The petitioner is engaged in the manufacturing of commercial motor vehicles in its factory and is also an HT consumer of the respondent Board. It is also stated in the petition that the Commission has granted consent to the petitioner for captive power plant vide order dated 29.5.2002 in Application No. 126/02 subject to the condition of minimum 50% use of power from Board's supply. Therefore, the petitioner requests the Commission to grant exemption from the condition to use 50% power from MPSEB supply as per the provisions of the Electricity Act, 2003.

The Commission informed the petitioner as per section 9 of the Electricity Act, 2003 (No. 36 of 2003) which has come into force on 10th June, 2003 no consent for installation and running of captive generating plant is required from the Commission. Therefore, the condition of use of 50% power from MPSEB supply is no more operative.

Ordered accordingly.
