## Petition No. 20 of 2006

### **SUB:- IN THE MATTER OF SUPERVISION CHARGES IMPOSED BY MPSEB FOR SHIFTING OF ELECTRICITY LINES AND ELECTRIFICATION OF NEW COLONIES UNDER THE SCHEME SPONSORED BY INDORE DEVELOPMENT AUTHORITY.**

### **ORDER**

**(As passed on this day of 13<sup>th</sup> June 2006)**

Shri P. L. Nene, Consultant and Shri T. S. Rajpal, Advisor, IDA appears on behalf of the petitioner.

Shri D. K. Ojha, Adtl. S.E., O/o CMD (WZ) appears on behalf of respondent.

2. The petition is filed in the matter of supervision charges imposed by MPSEB for shifting of electricity lines and electrification of new colonies under the schemes sponsored by Indore Development Authority.

3. During the course of hearing today the Respondent states that it has yet not received the copy of the petition as per the directions of the Commission.

4. During the course of hearing, on behalf of the petitioner Shri Nene submits that the supervision charges at the rate of 15% are being imposed on the petitioner by the respondent for all the electrification and shifting works related to the development of Indore city within the local limits of Nagar Nigam, Indore. Hence supervision charges should have been reduced from 15% to 5% as which is being charged from Municipal Corporation, Indore.

5. Having considered the facts and circumstances of the petition, Commission observes that Indore Development Authority may request the Municipal Corporation of Indore in this regard and as the development works are proposed to be done under master plan of Indore city the local bodies may move an application to the distribution licensee for shifting the poles and electricity transmission lines in public interest. The Commission directs the petitioner to seek the help of Indore Municipal Corporation to approach the licensee for shifting of the poles and the distribution licensee shall thereupon charge the same rate as is admissible in case of local bodies.

With the direction aforesaid, Commission decides to close the case.
