M. P. ELECTRICITY REGULATORY COMMISSION : BHOPAL

IN THE MATTER ALLOWING RUNNING TWO CAPTIVE POWER PLANT IN PARALLEL WITH MPSEB.

**ORDER
(Passed on this day 18th May, 2004)**

Shri P.L.Nene, Consultant appears for the petitioner.

None appears for the Respondent Board.

Petition is in the matter of allowing running two captive power plants in parallel with the MPSEB system. The case is listed for motion hearing today.

The petitioner submits that Jaypee Rewa Plant and Jaypee Bela Plant are under the same management. Two separate electricity connections have been availed from the MPSEB at the two plants. Separate captive power plants have been installed at Jaypee Rewa Plant and Jaypee Bela Plant. The petitioner further submits that the Commission vide order passed on 15.7.2003 have allowed the two plants to be inter connected. The Commission while approving the inter connection have also stipulated that the above captive power plants will not run in parallel with the MPSEB's supply. The petitioner submits that for each of the captive power plants, permission exists to run the individual captive power plants in parallel with MPSEB supply. However while transferring captive power through the Tie Line, the MPSEB supply will not be in parallel. The petitioner's interpretation of the order dated 15.7.2003 is that whenever the individual captive power plants are running in parallel with the MPSEB supply, the interconnection will be kept disconnected. The interconnection will only be operated when the plant at any of the places is not running in parallel with MPSEB supply. Thus there will not be any paralleling of the two MPSEB supplies. Suitable interlocking will be provided in consultation with the MPSEB.

As per the provisions of Electricity Act, 2003 (36 of 2003) which came into force on 10.12.2003 no consent for installation and running of captive generating plant is required in the present situation. As the MPERC (Grant of consent to run captive power plant) Regulation 2003 has been rescinded therefore the Commission is of the view that the petitioner should approach the Board and negotiate for the new terms and conditions. The case may be closed.

Ordered accordingly.
