The petitioners have jointly filed the subject petition for seeking approval of the Commission for implementation of Domestic Efficient Lighting Program (DELP) in pursuance to the proposal of M/s. Energy Efficiency Services Limited, New Delhi for distribution of LED bulbs in their respective area of supply under the provisions of MPERC (Demand Side Management) Regulation. The petitioners have requested the Commission to allow them to recover the cost of LED Bulbs in 5 monthly installments through the electricity bill of those consumers who opt for scheme and to enable them in exercising the provisions under Section 56 (Disconnection of supply in default of payment) of the Electricity Act 2003 and MPERC Supply Code 2013 on occurrence of default in payment of installments by consumers.
- 3. During the hearing, the Commission asked the petitioners to clarify the provisions under which the instant petition has been filed by them as the MPERC (Demand Side Management) Regulations are not yet notified by the Commission. The petitioners could not respond to the Commission's query. The instant petition being a premature filing, hereby dismissed.
