ORDER
Suo Motu Petition No. 03/05

Shri S.C.Goyal, Addl.CE,O/O CMD,(CZ),Bhopal appears on behalf of Central Discom. Shri Rajeev B Company Secretary appears on behalf of West Discom. Shri B.L.Kaurav, SE appears on behalf of E Discom.

2. During the earlier hearing on 24.10.2005, the Commission had directed the companies to ensure that all bills to be issued by the Discoms after 7.11.2005 are as per tariff order of 29.6.2005 and to ensure that the excess amount recovered from those category of consumers who have been billed on the basis of tariff prevailing before 15.7.2005, if any, is refunded through suitable adjustment in subsequent bills to be issued within a period of one month from 7.11.2005.

3. During the hearing on 16.11.2005, the representatives of the Discoms have made written submission to the Commission regarding compliance of directions of the Commission for implementation of tariff dated 29.6.2005 by 7.11.2005.

4. The Commission directs the Discoms to ensure suitable adjustment of the excess amount, if any, recovered from those category of consumers in subsequent bills.

5. With the above directions, the Suo-Motu Petition no. 03/05 stands closed.
