Shri B.K. Dubey and Shri D.K. Mundra, Deputy General Manager (Commercial) appears for the petitioner.

2. The petition is in the matter of grant of permission for wheeling of captive power generated from 2.5 MW Diesel Electric Generator.

- 3. During the last hearing Commission directed the petitioner to confirm under affidavit, whether the above two units form a Single entity i.e whether their income tax return is common.
- 4. The Respondent Board submits in its reply that the philosophy papers approved by the MPSEB (Board) has been submitted separately by Chief Engineer (Comm) Jabalpur vide their letter No. 05-01/3513 dated 17.11.2004 for consideration of Commission where in basis of calculation of wheeling charges & losses for conventional generating sources are proposed for 33 KV & 11 kV Distribution system.
- 5. The Commission is of view that the petitioner has confirmed on affidavit in another case that two units form a single entity and their Income Tax Return is common, hence this case may be closed.
