ORDER (Passed on this day 18th April, 2006)

Shri U. K. Sahasrabuddhe, Consultant appears for the petitioner.

Shri C. K. Dixit, Addl. S.E., O/o S.E.(0&M), MPSEB, Dewas & Shri B. K. Patel, S.E., (Urja Nigam), GoMP appear for the respondent Board.

- 2. The petition is in the matter under section 10(2) and 86(b) of the Electricity Act, 2003 for permission to sell electricity to the M.P. State Electricity Board.
- 3. The petitioner submits that he has installed WEGs at two locations i.e. at location 44 and 62 in the windfarms at Jamgodrani, Distt. Dewas under the incentive policy of the State Government dated 07.07.94 and 26.09.94. The energy generated by these WEGs are being delivered to the power system of the MPSEB through a meter at the windfarm since the date of its commissioning. As per the MPERCs order dated 27.08.2003 and amended order dated 01.03.2004 for a period of five years w.e.f. 15.04.2001, exemption from license and permission to sell electricity has been granted to the petitioner. Therefore, the petitioner prays to the Commission to grant permission to continue the sell power generated by WEG located at 44 & 62 to MPSEB from 15.04.06 onwards for a further period of 5 years @ Rs. 2.25/- per unit with a clause of revision in the rates to be fixed by the Commission.
- 4. The respondent submits in its written reply that the consent for exemption from license and sale of power generated from Wind Electric Generator (WEG's) at location No. 44 & 62 to MPSEB has been granted by the Commission for a period of five years w.ef. 15.04.01 through order dated 27.08.03 and 13.01.04 in Petition No. 114/03 and 222/03 respectively. The PPA for the same has been executed by the petitioner on 15.02.05 for both locations. The respondent also prays that the Commission may grant the permission for sale of electricity generated from WEG installed at location No. 44 & 62 Jamgodrani Distt. Dewas to MPSEB @ Rs. 2.25/- for the period of five years from the date of order of Commission.
- 5. Having heard both parties and considering the facts and circumstances of the case, the Commission grants permission to the petitioner for sale of electricity generated from WEG installed at location no. 44 & 62 at Jamgodrani Distt. Dewas to MPSEB w.e.f 15.04.2006 for five years @ Rs. 2.25 per unit or at the rate applicable as recently determined by the MPERC subject to the following other conditions:-
- i) The technical and other commercial matters should be settled between the respondent and the petitioner.
- ii) The wheeling of power shall be governed by the provisions of law to be made applicable from time to time and also as per terms and conditions of the PPA to be executed by the petitioner with the respondent.
- iii) The petitioner shall comply with the provisions of the Madhya Pradesh Vidyut Sudhar Adhiniyam 2000, and other laws applicable, the Regulation of the Commission, Technical Codes, Standards of Performance or any other guidelines issued by the Commission from time to time.
- iv) The petitioner shall furnish to the Commission such information required for the purpose of the discharge of the functions of the Commission, as the Commission may require from time to time.
- v) The Commission shall be entitled to impose any other conditions as the Commission considers appropriate from time to time, including the terms of revocation or modification of the approval.

Ordered accordingly.
