ORDER

Shri B.K. Dubey, Advocate appears on behalf of the Petitioner.

Petition is in the matter of WEGs upto 2.5 MW capacity in the District of Dewas (M.P.) and in the matte wheeling of power to additional point of consumption at Plot No. 1, Sector-D, Mandideep Distt. Raisen.

Petitioner is a company engaged in the manufacturing of commercial motor vehicles and requires consumptio power and is wheeling power upto 2.5 MW capacity through the lines of MPSEB to it's factory at Pithampur vide (19/05/2004 in petition No. 20/04. The petitioner submits to the Commission to grant permission for wheeling of i through WEGs to Tractor Division at Mandideep, owned by the petitioner in addition to wheeling of power to its ma petition had been filed before the Hon'ble High Court of M.P. bench at Indore in the matter of merger of Eicher Ltd. v which was registered at S. No. 04/2004 and vide order dated 28.07.04 the same has been allowed in favor of the consequence of the order, dated 28.07.04, the Tractor Division owned by the Eicher Ltd. at Mandideep is now a u petitioner.

The representative of the Board requests the Commission to grant consent to the Petitioner for captive use by \(\infty\) Division, Mandideep vide the conditions mentioned in Commission s order dated 19/05/04 alongwith additional c percentage/ ratio of electricity generated will be used by Pithampur and Mandideep plant for which a month-wise sche for wheeling to the petitioners Pithampur and Mandideep plant before the date of commissioning of WEG be submitted

Considering the facts and circumstances of the case Commission grants permission to the petitioner to wheel Mandideep plant besides its factory at Pithampur on the condition of payment of wheeling charges as per the existing State Government for five years from the date of this order subject to revision to be made by the Commission, will per of fixed percentage to be wheeled to Pithampur and Mandideep factory be intimated to the Board in advance, for pro energy by the respective accounting units of the Board. Commission also directs that in the event of any one unit go not have any objection in adjusting the supply to the remaining unit. The above permission is subject to the following

- The technical and other commercial matters should be settled between the Board and the petitioner.
- ii) The supply and sale of power shall be governed by the policy of the State Government and other pi applicable from time to time and also as per terms and conditions of the PPA executed by the petitioner with t
- iii) The petitioner shall comply with the provisions of the Madhya Pradesh Vidyut Sudhar Adhiniyam 2000, El laws applicable, the Regulation of the Commission, Technical Codes, Standards of Performance or any oth Commission from time to time.
- iv) The petitioner shall furnish to the Commission such information required for the purpose of the disch Commission, as the Commission may require from time to time.
- v) The Commission shall be entitled to impose any other conditions as the Commission considers app including the terms of revocation or modification of the approval.

Therefore, in view of aforesaid, the Commission decides to close the case.
