ORDER

(Passed on this day 24th October 2007)

Shri P.L. Nene, Consultant appears on behalf of the petitioner.

Shri R.D. Koshti , ASE appears on behalf of the Respondent.

- 1. The petitioner has submitted this petition in the matter of non-availability of uninterrupted supply of power because of giving supply to other consumers from their dedicated feeder.
- 2. During the course of last hearing on 16.10.2007, in response to the specific query by the Commission, the petitioner confirmed and agreed to complete the formalities / agreements for availing supply from the respondent for a period of 5 years for the present contract demand. The Commission directed the respondent to finalize whatever required formalities / agreements that are to be concluded in the matter. The East Discom requested to the Commission to give one week's time for completing necessary contract agreements, if any, and to draw out a definite time-frame for completion of the work. The Commission granted time and directed the East Discom to submit the above information three days before the next date of hearing.
- 3. The respondent in its reply has submitted that for providing separate 33 KV line for the plant of petitioner, 33 KV line on Rail Pole will be laid for a route length of about 4.5 Km, which involve 8 No. 33 KV and 4 No. 11 KV crossings. The line shall also pass through the residential townships mostly in urban areas. Keeping in view the above factors, the respondent expects that the proposed line will be completed and commissioned within a period of 4 months.
- 4. During the course of hearing today, after having considered the submission made by both the parties, the Commission directs the respondent to ensure the erection of the line on or before 31.03.2008 for supplying uninterrupted and quality supply to the petitioner. The petitioner had also agreed for the time framed. The Commission also directs the respondent and petitioner to sign the PPA within 15 days.
- 5. With the directions aforesaid, the Commission decides to close the case.

Ordered accordingly.
