ORDER (Passed on this day 19th July, 2005)

Shri B.K. Patel, Superintending Engineer, Bhopal appears on behalf of the Petitioner.

Shri D.K. Ojha, Addl. S.E. O/o. CMD (WZ), Indore appears on behalf of M.P. Paschim Kshetra Vidyut Vitaran Company Ltd., Indore.

- 2. The petition is in the matter of sale of power to utility generated by wind firm proposed at Mamat Kheda Distt. Ratlam.
- 3. Petitioner is a nodal agency and has proposed a 2 MW wind farm project under demonstration wind farm scheme of Ministry of Non-conventional energy sources. The petitioner have proposed the sale of power generated by this wind farm to MPSEB as per rates mentioned in the Commission's Order dated 11.06.04. The petitioner has requested the Commission to give clearance and direct the MPSEB for signing the PPA with the petitioner.
- 4. During the course of last hearing the Board agreed for granting consent to the petitioner for purchase of power generated from proposed 2 MW wind farm project at Mamad Kheda to MPSEB. Commission directed the petitioner to execute an agreement with MPSEB and decide the rates as per Commission s Tariff Order.
- 5. Commission observed that no comments have been submitted by the petitioner on the Draft National Tariff Policy. The Commission directs the petitioner and the Board to act as per the agreement to be executed between them.

Therefore, in view of the aforesaid Commission decides to close the case.

Ordered accordingly.
