Petition is in the matter of reviewing the order dated 25.01.2005 in Petition No. 122/04 u/s 7 and 10(2) of the Electricity Act, 2003 for granting ex-post-facto approval for the supply of power generated by M/s Steel Tubes of India Ltd., Dewas to the Board as deemed sale during the period of disconnection.

3. Having heard the parties, Commission finds no valid ground to review its order dated 25.01.2005. Therefore, Commission decides to reject this review petition with the directions to the petitioner to make payment of the energy bills revised by the respondent for deemed sale as per Commission's order dated 25.01.2005. Compliance report be submitted within a period of one month from the date of the order.
