3. Parties were heard on the merits of their respective views

4. Having heard the petitioner and the representatives of the Distribution Companies, we find force in the contention of the petitioner and the arguments put forward by the respondents as well. The petitioner is seeking facility of feed extension in Mangliyagaon high tension supply agreement, entered into with the respondent

Distribution Company on 05.12.2011, on the same terms and conditions as were provided in all other HT agreements executed earlier with the erstwhile MPSEB without considering the excess demand for billing purpose in terms of the Retail Supply Tariff Order.

5. The issues involved in the petition are linked with the Retail Supply Tariff Order for FY 2013-14 issued by the Commission. Therefore, the Commission is not inclined to take any decision which may amount to review of the Tariff Order at this stage. The petitioner is advised to approach the Commission at the time of processing the forthcoming petition to be filed by the respondents for determination of ARR and retail supply tariff for FY 2014-15.

Ordered accordingly.
