## ORDER (Passed on this day 13<sup>th</sup> December, 2005)

Shri U.K. Sahasrabuddhe, Authorized Representative appears on behalf of Petitioner.
Shri C. K. Dixit, Addl. S.E., O/o CMD (WZ) appears on behalf of M.P. Paschim Kshetra Vidyut Vitaran Company Ltd., Indore.

- 2. The petition is in the matter of permission to sell electricity to MPSEB for the period 01/08/2003 (for location 46 and 49) and from 01/06/2003 (for location 30) to 12/07/2004 to be treated as deemed sale as per PPA agreement.
- 3. During the course of hearing on 08/11/2005, Commission directed the petitioner to make available the data of power purchase and the average cost incurred during the relevant year when power had been received from the petitioner.
- 4. The case is listed for hearing today. The respondent submits in its written reply that data of the average rate at which MPSEB purchased power during the period for the power injected by the petitioner in the Board's system.
- 5. Today Commission heard both the parties. Commission does not agree with the reply submitted by the Respondent. Commission has directed earlier in other cases to pay for deemed sale of power @ Rs. 2.25 per unit as per the notification of GoMP. Therefore the Commission directs the respondent that generation for the period from 01/08/2003 to 12/07/2004 for WEG location 46 and 49 from 01/06/2003 to 12/07/2004 for location 30 also be treated as deemed sale and the Board shall pay to the petitioner @ Rs. 2.25 per unit subject to the revision by the Commission in pending review petition.
