ORDER **Date: 9.8.2005**

Sub: In the matter of review petition in P-3/05- Order passed dated 29.6.2005

_ Shri Ashok Kumar Jain appears on behalf of petitioner.

Shri M.K.Gupta, SE (O&M), MPSEB, Bhopal appears on behalf of M.P.Madhya Kshetra Vidyut Vitaran Company Limited, Bhopal as respondent and submitted written reply.

2. The Commission heard the representatives of petitioner and respondent. The petitioner made a request to review the tariff for HT Irrigation and Public Water Works under tariff order dated 10.12.2004 and dated 29.6.2005 on the ground that the tariffs increase were very high.

3. The Commission directs that the case for review of tariff order dated 10.12.2004 is now time barred and no longer applicable, therefore the case for review of tariff order dated 10.12.2004 is liable to be rejected.

4. The Commission also directs that no new grounds such as error apparent or submission of new facts have been put forth by representative of the petitioner for review of tariff schedule for HT Irrigation and Public Water Works under tariff order dated 29.6.2005 and therefore this petition is liable to be rejected. However, the petitioner may approach to the " Appellate Tribunal for Electricity", New Delhi for appeal within specified time against the tariff order dated 29.6.2005.

5. The Commission further clarifies that the tariff schedules-7 of order dated 10.12.2004 and HV-5 of order dated 29.6.2005 for Lift Irrigation Schemes is applicable to both Government and Private Lift Irrigation Schemes and if any Lift Irrigation Scheme is run by private person and the connection is at 33 KV or 11 KV, this tariff is applicable.

6. With the clarifications given in para- 5, the petition no. 79/05 stands closed.
