No. -1381./MPERC/2020 - In exercise of power conferred under section 181(2) (zd) read with Section 45 and section 61 of the Electricity Act 2003 (No. 36 of 2003) ,the Madhya Pradesh Electricity Regulatory Commission hereby makes the following amendments in the "Madhya Pradesh Electricity Regulatory Commission (Terms and Conditions for Determination of Tariff for Supply and Wheeling of Electricity and Methods and Principles for Fixation of Charges) Regulations, [2015(RG-35(II) of 2015]".

Whereas, the Commission had notified Madhya Pradesh Electricity Regulatory Commission (Terms and Conditions for Determination of tariff for Supply and wheeling of Electricity and Methods & Principles for Fixation of Charges) Regulations, (Second Amendment) Regulations, [2015(RG-35(II))(ii) of 2015on 14<sup>th</sup> November 2019 is applicable up to 31<sup>st</sup> March, 2021. In order to specify the terms and conditions for Distribution Tariff for the next Financial Year 2021-22, these Regulations are being amended.

## **Short title and Commencement:**

- (i) These Regulations shall be called the "Madhya Pradesh Electricity Regulatory Commission (Terms and Conditions for Determination of Tariff for Supply and Wheeling of Electricity and Methods and Principles for Fixation of Charges) (Third Amendment) Regulations, 2015"
- (ii)These Regulations shall come in force with effect from 01.04.2021, and unless reviewed earlier or extended by the Commission, shall remain in force for a period of one year, i.e., up to 31.03.2022.Except for the following amendments, all other provisions and term & conditions of principal Regulations shall remain unchanged.
- (iii) These Regulations shall extend to the whole of State of Madhya Pradesh.

## Amendment to Regulations 1.3, 8.1, 8.4, 16, 17.1, 25.1, 31.3,34.6 (b) (i) and (ii)

- In Principal Regulations, under Regulations 1.3, 8.1 and 16 the word "31st March 2019" shall be substituted by the word "31st March 2022".
- In Principal Regulations, under Regulations 8.4, the word "31st October every year" shall be substituted by "31st December for FY2021-22".
- In principal Regulations, under Regulations 17.1, the word "threeyears" shall be substituted by the word "Six years".

In Principal Regulations, under Regulations 25.1, the normative distribution loss level trajectory for control period of these Regulations shall be substituted as per table below
