No. 2545-MPERC-2013.—In exercise of the powers conferred by sub-section (1) and clause (z j), (z k) and (z l) of sub-section (2) of Section 181 read with sub-section (1) and (2) of Section 91 and sub-section (1) of Section 92 of the Electricity Act, 2003 (No. 36 of 2003), the State Commission, hereby, makes the following amendments in the Madhya Pradesh Electricity Regulatory Commission (Conduct of Business) Regulations, 2004, wich was notified on 30th July 2004.

Second amendment to Madhya Pradesh Electricity Regulatory Commission (Conduct of Business) Regulations, 2004

- 1. Short title and commencement.— 1.1 These Regulations shall be called the "Madhya Pradesh Electricity Regulatory Commission (Conduct of Business) Regulations, 2004 (Second Amendment) [AG-10 (ii) of 2013].
 - 1.2 These Regulations shall extend to whole of the State of Madhya Pradesh.
- 1.3 These Regulastions shall come into force from the date of their publication in the Gazette of the Government of Madhya Pradesh.
- 2. Amendment to MPERC (Conduct of Business) Regulations, 2004.—(i) In regulation 3, for sub-regulation (6), the following sub-regulation shall be substituted, namely:—
 - "(6) The Commission may hold sittings for hearing matters at the headquarters or at any other place on days and time to be specified by the Commission."
 - (ii) In regulation 20, for sub-regulation (1), the following sub-regulation shall be substituted, namely:—
 - "(1) The members of the Commission, who heard the matter shall pass an order on the petition."
