No 986./MPERC/ - In exercise of powers conferred under Section 181(1) read with Section 91(4) of the Electricity Act, 2003 (No. 36 of 2003), the Madhya Pradesh Electricity Regulatory Commission hereby makes the following amendment in MPERC (Appointment of Consultants) (Revision-1) Regulations, 2009 which was notified on 30.01.2009 in M.P.Gazette. Namely-

SIXTH AMENDMENT TO MADHYA PRADESH ELECTRICITY REGULATORY COMMISSION (APPOINTMENT OF CONSULTANTS) (Revision – 1) REGULATIONS, 2009.

- 1. Short title and Commencement: (i) These Regulations may be called the Madhya Pradesh Electricity Regulatory Commission (Appointment of Consultants) (Revision 1) (Sixth Amendment) Regulations, 2009 {ARG-6(1)(v) of 2021}.
- (ii) These Regulations shall come into force on the date of their publication in the M.P. Gazette.
- (iii) These Regulations shall extend to the entire State of Madhya Pradesh.

2. Amendments to Regulation 5 (1)

In the Principal Regulations, the Regulation 5(1) shall be substituted as under:-

5(1) (a). Individual Consultants will be categorized into one of the four levels of Advisor, Senior Consultant, Consultant and Research Fellow based on their expertise and experience.

Additionally, there would be three positions of Research Fellows in each of the disciplines indicated in the table above. The Research Fellows should have acquired the desired minimum qualifications in the respective fields within three years preceding the date of initial appointment in the Commission.

The appointment of Research Fellows shall be on Consultancy basis, initially for a

period of one year, may be extendable maximum up to three years. The Research fellow shall be entitled to a consolidated remuneration as decided by the Commission but shall not exceed Rs 40000 (Rs forty thousand) per month.

3. Amendment to Regulation 6

In the Principal Regulations, the Regulation 6(1) read with third Amendment to Madhya Pradesh Electricity Regulatory Commission (Appointment of Consultants)(Revision-I) Regulations, 2009 notified on 8th Mar, 2013 for the words 'twenty five' the word 'forty' was substituted. Now with this amendment the word 'forty' shall be substituted by the word 'eighty'.

In the Principal Regulations, the Regulation 6(2), Remuneration per day for 'Advisor', Sr. Consultant and Consultant shall be substituted by Rs 3000/-, Rs 2000/- and Rs 1500/- in place of Rs 2500/-, Rs 1500/- and Rs 1000, respectively.
