In exercise of the power under sub-section (5), (6) & (7) of Section 42 read with clauses (r) & (s) of sub-section (2) of section 181 of the Electricity Act, 2003 (No. 36 of 2003) and all powers enabling it in that behalf, M.P. Electricity Regulatory Commission hereby makes following amendment to the Regulation "Madhya Pradesh Electricity Regulatory Commission (Establishment of Forum and Electricity Ombudsman for redressal of Grievances of the Consumers) Regulations, 2004 notified vide no. 1003/MPERC/2004 dated 12th April, 2004.

SECOND AMENDMENT TO MADHYA PRADESH ELECTRICITY REGULATORY COMMISSION (ESTABLISHMENT OF FORUM AND ELECTRICITY OMBUDSMAN FOR REDRESSAL OF GRIEVANCES OF THE CONSUMERS) REGULATIONS, 2004

1. Short Title and Commencement:

(i) These Regulations may be called the "**Madhya Pradesh Electricity Regulatory Commission (Establishment Of Forum And Electricity Ombudsman for Redressal of Grievances of the Consumers) Regulations, 2004 (Second Amendment) (No. AG-3 (ii) of 2006)**".

(ii) These Regulations shall come into force with effect from the date of its publication in the official gazette.

(iii) These Regulations shall extend to the entire State of Madhya Pradesh.

2. Amendment to Chapter 4:

In the **Madhya Pradesh Electricity Regulatory Commission (Establishment of Forum and Electricity Ombudsman for Redressal of Grievances of the Consumers) Regulations, 2004, Sub-clause (c) of clause 4.10** shall be substituted namely:

"(c) The Ombudsman shall be part and parcel of the Commission's office and expenditure in this regard shall be borne by the Commission."
