

**Madhya Pradesh Electricity Regulatory Commission, Bhopal**

**Bhopal, Dated 18<sup>th</sup> June, 2025**

No. 1142/MPERC/2025 - In exercise of powers conferred under Section 181(1) read with Section 91(4) of the Electricity Act, 2003 (No. 36 of 2003), and all other powers enabling in this behalf, the Madhya Pradesh Electricity Regulatory Commission hereby makes the following amendment to amend Madhya Pradesh Electricity Regulatory Commission (Appointment of Consultants) (Revision-1) Regulations, 2009 herein after referred to as the “**Principal Regulations**”, namely-

**Seventh Amendment to Madhya Pradesh Electricity Regulatory Commission (Appointment of Consultants) (Revision-1) Regulations, 2009**

**1. Short title and Commencement:**

1.1 These Regulations may be called “**Madhya Pradesh Electricity Regulatory Commission (Appointment of Consultants) (Revision – 1) (Seventh Amendment) Regulations, 2009 {ARG-6(I)(vii) of 2025}**”.

1.2 These Regulations shall come into force from 1<sup>st</sup> April, 2025.

**2. Amendment of Regulation 5 of Principal Regulations**

2.1 **In Regulation 5 of the Principal Regulations, Regulation 5(1)(b) shall be substituted by the following, namely:**

“5(1)(b) The Qualification, Minimum Experience of Advisors, Sr. Consultant, Consultant and Research Fellow shall be as below:

Upto maximum of 08 nos. Research Fellows may be engaged in aforesaid four Disciplines, and the Commission shall decide the number in each discipline.”

**2.2 In the above said Regulation, a new sub-Regulation 5(3) shall be inserted after sub-Regulation 5 (2) namely:**

“5(3) The experience as research fellow in the commission shall be considered for appointment as consultant subject to other criteria being fulfilled and the suitability of the candidate for appointment as individual consultant.”

**3. Amendment to Regulation 6 of Principal Regulations**

**3.1 In Regulation 6 of the Principal Regulations, Regulation 6(1) shall be substituted by the following, namely:**

“6.1 For individual Advisor, Sr. Consultant, Consultant & Research fellows engaged on monthly basis, a consolidated remuneration shall be paid, as may be decided by the Commission from time to time, but shall not exceed as below: -

Type of Consultant	Maximum Amount payable in INR
Advisor	1.50 lakhs
Sr Consultant	1.25 Lakhs
Consultant	0.80 lakhs
Research Fellow	0.60 lakhs*

\*The Remuneration for the Research Fellow on first induction shall be consolidated remuneration of Rs. 40,000/-, subject to following: -

- i. Research Fellow shall be inducted initially for the period of one year and his/her tenure may be extendable maximum upto 5 years based on their performance and requirements of MPERC.
- ii. The consolidated remuneration shall be increased to Rs. 44,000/- in Second Year, Rs. 48,000/- in third year, Rs. 52,000/- in fourth year and Rs. 56,000/- in fifth year; if the contribution of the research fellow in the research work is found satisfactory by the Commission in respective years.
- iii. Other terms and conditions as stipulated in the order issued at the time of induction.

**3.2 In the above said Regulation, Regulation 6(2) shall be substituted by the following, namely:**

“ 6.2 For service on daily basis/per advice basis, remuneration per day/per advice shall be as follows subject to the condition that engagement on daily rate/advice shall not be normally for more than 10 working days/advices during one month and 90 working days/advices during one year:
