THIRD AMENDMENT TO MPERC (APPOINTMENT OF CONSULTANTS) REGULATIONS, 2004

1. Short Title and Commencement

- (i) These Regulations may be called the "Madhya Pradesh Electricity Regulatory Commission (Appointment of Consultants) Regulations 2004 (Third Amendment) (AG-6 (iii) of 2006)".
- (ii) These Regulations shall come into force with effect from the date of their publication in the official gazette.
- (iii) These Regulations shall extend to the entire State of Madhya Pradesh.
